. Liability Indemnification

The herding training and the herding courses are based on training methods which we deem to be optimal. Each participant is responsible for her/his own dog. Any instructions of the trainer have to be complied with.

Part of the training is the direct contact of the dogs and the handlers with sheep, ducks and cattle. Liability claims in case of non-compliance with the directions of the trainer remain reserved. All participants are aware that no risks can be excluded in case of direct contacts with living animals.

S Bar L excludes any liability for actions of third parties. Any liability is restricted to intention and gross negligence. The liability for secondary- and financial damages (e.g. loss of profit) in case of negligence is excluded. The training takes part sometimes on sandy ground in a building, partly on natural ground like grassland. Any liability in cases of the general risks of life like stumbling, contact with animals and comparable cases are excluded.

Without the explicit allowance of S Bar L, no video recording, handy pictures and recording, graphic material is accepted. In case of not allowed usage or publication any claims for forbearance and damages remain reserved.

Privacy statement according to the DSGVO

General information about data processing

1. Scope of processing of personal data

In principle, we only collect and use the personal data of our students, event participants and buyers insofar as this is necessary to provide a functional website and to fulfill the business relationship. The collection and use of personal data of our students, event participants and buyers is usually only with the consent of the respective person. An exception applies to cases in which prior consent can not be obtained for reasons of fact and the processing of the data is permitted by law.

2. Legal basis for the processing of personal data

Insofar as we obtain the consent of the data subject for processing of personal data, Art. 6 para. 1 lit. a DSGVO as legal basis. In the processing of personal data necessary for the performance of a contract to which the data subject is a party, Art. 6 para. 1 lit. b DSGVO as legal basis. This also applies to processing operations required to carry out pre-contractual actions. Insofar as the processing of personal data is required to fulfill a legal obligation (statutory provisions) which is governed by our association (eg federal registration laws), Art. 6 para. 1 lit. c DSGVO as legal basis. If processing is necessary to safeguard the legitimate interests of our company or a third party, and if the interests, fundamental rights and freedoms

of the data subject do not ., Art. 6 para. 1 lit. f DSGVO is legal basis for processing.

3. Data deletion and storage duration

The personal data of the data subject will be deleted or blocked as soon as the purpose of the storage is deleted. In addition, such storage may be provided for by the European or national legislator in EU regulations, laws or other regulations to which the controller is subject. A blocking or deletion of the data takes place even if a storage period prescribed by the mentioned standards expires, unless there is a need for further storage of the data for the fulfillment of the purpose.

Your Rights

If your personal data are processed, you are the person who concerns it in the meaning of the DSGVO and you have the following rights to the person responsible:

You have a right to information about the personal data stored about you, about the purpose of the processing, about possible transfers to other places and about the duration of the storage.

If data is inaccurate or no longer necessary for the purposes for which it was collected, you may request that the processing be corrected, deleted or restricted. As far as provided in the processing procedures, you can also view your data yourself and correct it if necessary.

Should your particular personal situation give rise to reasons against the processing of your personal data, you may object to this insofar as the processing is based on a legitimate interest. The controller will no longer process the personal data concerning you unless he can demonstrate compelling legitimate grounds for processing that outweigh your interests, rights and freedoms, or the processing is for the purpose of enforcing, exercising or defending legal claims.

You have the right to revoke your data protection declaration at any time. The revocation of consent does not affect the legality of the processing carried out on the basis of the consent until the revocation. The revocation must be in writing.

Right to complain to a supervisory authority

As the data subject, you have the right to lodge a complaint with a data protection supervisory authority, in particular in the Member State of its residence or the place of the alleged infringement, without prejudice to any other administrative or judicial remedy, if you consider that the processing of the personal data concerning you violates the data safety.

The regulator that files the complaint will notify you of the status and outcome of your complaint, including the possibility of a judicial remedy. The competent supervisory authority is: Bavarian State Office for Data Protection Supervision (BayLDA), Promenade 27, 91522 Ansbach

**General terms and conditions for events, seminars, individual training,
group training and lectures
S Bar L Sandra Zilch herding dog school**

§1 service description

The contractually agreed services are set out in the description of services in the seminar description or in the information in the confirmation of participation and / or invoice from S Bar L Sandra Zilch Hütehundeschule. The information contained in the invitation to tender and / or in the confirmation of participation is binding. S Bar L Sandra Zilch Shepherd Dog School, henceforth called Organizer, reserves the right, however, for materially justified, significant and unpredictable reasons to declare a significant change to the seminar invitation, which will inform the participant before the start of the event. In this case, the participant has the right to withdraw from the event within 10 days and will immediately be refunded the possibly paid participation fee. If he does not cancel within this period, the new service description is tacitly accepted.

The organizer reserves also necessary short-term and minor changes as well as temporal shifts. However, the organizer endeavors to come as close as possible to the contract

objective.

The participant may assert any warranty claims only against the respective provider of the service (eg hotel owner). The organizer is liable only for his own contractual obligations.

§2 Conclusion of the contract (registration)

By registering the participant offers the organizer the conclusion of the contract binding. Registration takes place in writing by the applicant for all participants listed in the registration. The applicant stands by as for his own obligation. The contract is concluded with the acceptance by the organizer and does not require any specific form.

§3 payment

The seminar fee is due with the registration. I reserve the right to award seats in the order of receipt of payment.

§4 resignation by the participant

The participant can withdraw at any time before the start of the service. The resignation must be in writing (for example per E-Mail). The decisive date for the declaration of withdrawal is the time of receipt by the organizer.

In the case of resignation, the organizer may demand compensation for the arrangements made and for his expenses.

The cancellation costs are:

Until 6 weeks before start: 10% of the participation fee.

Until 4 weeks before the start: 30% of the participation fee.

In case of withdrawal from two weeks before the start of the event no refund will be made.

Unused services will not be refunded.

Free places in a comparable subsequent seminar can be transferred to this. This is done at the discretion of the organizer.

§5 resignation by the organizer

The organizer can withdraw from the contract:

Without observing a deadline, if the participant behaves contrary to the contract, in particular the goal of the event, other participants or animals are endangered.

Up to two weeks before the start of the event, if the required minimum number of participants is not reached.

If the course leader fails, there will be reimbursement of the pro-rated participation fee.

Free places in a comparable subsequent seminar can be transferred to this. This is done at the discretion of the organizer.

§6 Liability of the organizer

The organizer is liable only for damage caused intentionally or grossly negligently by him.

The organizer is not liable for damage caused by third parties and their dogs or other animals. Each participant undertakes to have a pet owner liability insurance. However, the S Bar L Sandra Zilch Hütchenschule is not obliged to refer to the assertion of its claims against the insurance.

§7 film and sound recordings

The participant declares his express consent to the use and publication of film / photos of his animal /s during a seminar or an event. The S Bar L Sandra Zilch herding dog school commits itself to restrict the publication of film / photo recordings exclusively to the content

design of trade publications, textbooks, teaching and training materials. The participant waives the assertion of any remuneration.

Film / photo shootings by participants during a seminar or one of the offered other events and training hours are expressly prohibited.

§8 obligations to cooperate

The participant is obliged to avoid damage or to keep it low in the case of performance disruptions. Complaints must be made immediately to the organizer, otherwise any claims are excluded.

§9 Limitation of claims

Claims expire in accordance with the statutory provisions.

§10 Ineffectiveness of individual provisions

The invalidity of individual provisions does not result in the ineffectiveness of the entire contract.

§11 Jurisdiction

Autobahn A3 from north:
